1. What are steps for User ID creation/Login Process?

Steps to follow

- Step 1.

User will received 3 Mails as below Subject

- Genisys - User Credentials
- Genisys - User Id Details
- User Activation Code

- Step 2.

Every mail will have below link, which needs to be open from internet explorer <https://hegc.hdfcergo.com/Configurator>

Below screen will open on click of link



- Step 3.

Click on link “Click Here To Login“

Below Screen will open on click of it.



- Step 4.

Enter User Id from Email subject “Genisys - User Id Details”

Enter Password from Email “Genisys - User Credentials”

Click on Login Button then system will show below screen



- Step 5.

Activate button will be displayed on screen



- Step 6.

On Click of Activate User Link system will display below screen.

Then enter the same credentials entered in previous screen.

Enter the activation code which is received from email “User Activation Code”

Then click Save Button

- Step 7.

On click of Save Button, system will display below screen to Change your password. Old Password for 1st time users will be from mail subjected "Genisys - User Credentials."

- Step 8.

On successful saving you will be able to login from below given link to GC. Post activation date, System will take one day to activate same in PIE. Note- To have access in PIE, user should be created in GC (ACTIVE) and should have appropriate role configured.

Answer:

- A. If you are getting above error message, Please follow the below steps -
 3. Please click on 'Forgot Password?' Option provided on Login Page.
 4. Enter User name, Security Question and Answer.
 5. Click on Submit.
 6. You will receive a Password email on your registered email id.
 7. Please login with revised Password.
- B. You can also use 'Reset Password' option provided in GC to reset your Password. After successful password reset, login in PIE with new Password.
- C. If your user id was created in GC today then it will be active in PIE on next day. Hence, in case of new User id, user needs to try login into PIE application on next day.
- D. If problem still persist, please send your mail to PIE.SUPPORT@HDFCERGO.COM by mentioning your User ID and error screenshot.

2. Who can Login into PIE application?

Answer:

- A. User's belongs to 'Intermediary' category and having valid User id in GC can login into PIE application with same Login Credentials as that of GC.

- B. Also, users with 'Sales' category can also get access of PIE application. For this, User id should be created against correct Primary Sales Manager's (PSM) Code.
